Here is a brief overview of the Video Competition for 2022:

<u>Videos</u>

- Video recordings must be unedited and the full competition package no breaks in the recording.
- Video should be set up to best see whole chorus.
- Smart phones and tablets can be used for recordings.
- You may have a live audience during recordings.
- Recordings must be made 1-4 weeks before submission. They are due to region on April 4, 2022.
- If videos are not submitted on time, it is like not showing up on the contest stage (a forfeit).
- Each chorus will also be asked to submit a chorus/quartet photo with their video to be used to display winners in Pitchpipe. Can be contest or another photo.

Make-Up/Costumes/Staging/Lighting

- Stage makeup is not required, but makeup should be worn to "look good" on video.
- Special stage lighting is not required.
- Masks are allowed for those who wish to wear them. The judges have been trained for every aspect of a virtual competition.
- Costumes your quartet or chorus should wear an appropriate costume for competition.

Iudging

- Judges are being trained to be experienced with all levels of video quality.
- Judges will judge videos on scheduled contest weekend.
- Order of Appearance will be drawn just like past contests. In video each contestant will indicate "contestant number, name of chorus and where they are from and directed by".

Results

- Results will be presented on Facebook Live at noon during a viewing of the videos at the "Virtual Convention", April 23, 2022
- You cannot show videos until **after** the video presentation on April 23, 2022.
- Score sheets and medals/trophies will be mailed/delivered after receiving the videos from the Competition Coordinator and prior to the scheduled virtual convention on April 23, 2022.



Director FAQs for Video Recording 2022 Regional Conventions

As you prepare to make your video recording of your ensemble for contest, we know that can raise a number of questions about how best to do it. We deeply appreciate and honor your desires to create "optimal" recording conditions to best showcase your chorus. However, please remember that the goal is have the opportunity to perform for feedback once again and receive education and guidance about moving forward from this new beginning. Technology is much better than we even realize and we are confident that you can make an excellent video recording without a great deal of stress or expense!

Our judges are trained throughout the International Judging Program using videos. Level-viewing prior to all contests is conducted using video recordings from multiple competition venues with varying acoustics, technology, and lighting. We are conducting specific judge training in the coming months concerning our upcoming regional contests. Our judges are extremely competent and confident judging contests via video.

We are providing our judges with video examples of choruses and quartets with the following variations:

- Video recordings made on a smart phone, a tablet and a laptop with microphone attached
- Video recordings with masks and without masks
- Video recordings with and without social distancing used
- · Video recordings with overhead lights only and with additional lighting
- All of these conditions will be reviewed in these video recordings and studied with both ballads and up-tunes

In preparing and reviewing these recordings, the Judge Specialist Committee has compiled a few thoughts you'll want to keep in mind as you prepare for recording.

Please keep the following in mind as you prepare for recording:

- Video and sound quality from ordinary smartphones and tablets is ample. After reviewing all of the options, actually the videos made with a smart phone or tablet were the best recordings! These provided clear sound and visuals for us that we could judge with clarity and precision.
- 2. **Special lighting is not necessary.** Standard overhead lighting is sufficient. In the recordings, the additional lighting was barely noticed as long as the overhead lights were bright.
- 3. Camera placement should capture the entire ensemble if possible. To enhance sound and blend, we discovered it is best accomplished by moving the recording device further back and then use the zoom feature to bring the group into closer view. This allows the voices the space to blend better before reaching the microphone for recording.

- 4. Video close-ups and panning are not necessary. If you have someone that can do it with smooth motion, it can work if you desire. However, it can be disorienting for the viewer to have it move too quickly or jerkily and actually detracts from the ability of the judge to watch you consistently.
- 5. Sound quality is only minimally impacted by mask wearing. It was a pleasant surprise to find that there was almost NO discernable difference between recordings made with masks on or with masks off. Please feel free to use masks if that is what your area requires or if that is what helps your singers feel safe.
- 6. Sound quality is only minimally impacted by social distancing. It can be a bit disconcerting for singers to be farther away from other chorus members and to not hear them as well. So make sure to begin practicing and using the distance/placement you plan for contest in your rehearsals now so they have time to get used to singing confidently even when socially distanced.
- 7. Sound quality is only minimally impacted by varying acoustical conditions in typical rehearsal halls. Our recordings were made in a variety of places from large, spacious rooms to small areas. Some had tall ceilings; some low ceilings. There was little difference in the quality of the recording. Help your singers get confident with singing their best vocal production in the space that you will record in.
- 8. If masked, Visual Communication judges still have ample ways to accurately judge the group. While the Visual Communication judges may not be able to see smiles or all of the face, they can easily see bodies and lifted countenance. Even if you need a greater distance to video (a larger group) and are unable to move in closer at times, free, natural and dynamic bodies communicate a great deal! Lifted faces can often be seen even in masked groups. Performing with the song's message and emotional intent can happen with or without a mask. Keep reminding your performers to forget the mask and sing from their heart!
- 9. What if some groups make more than one recording? There really is no way we can regulate this. However, as judges, fellow directors and performers, we can tell you our experience with this. Short of something crazy happening when making the video (which might happen! If so, please re-record it!), recording the songs over and over really doesn't change the score. Often we get more tense the more times we do it, creating other issues which actually negatively impacts the score. Also, it is required that it be one continuous recording from announcement to final bow. We want you to feel confident in your performance, but be judicious about re-doing it multiple times.

There will be lots of groups recording their contest video this year! Share your experiences with one another. Help each other figure out what worked best for you. Communicate your successes as well as your questions. You have many cheerleaders and supporters as you move forward into this exciting venture!



VIDEO SUBMISSION PROCEDURES

These procedures are intended for any competitor who will not be attending a live, inperson regional contest **and** who will be recording their own performance for submission into their regional contest to receive adjudication.

Contest Divisions:

<u>International Division</u> or <u>Evaluation Only</u> competitors: perform and submit two (2) contest songs.*

Open Division competitors: perform and submit one (1) contest song, at least one (1) non-contest song, and emcee work.

*Competitors are only eligible to submit a video in the International Division in a region holding a Video Contests.

Submitted performances are subject to all contest rules, such as timing, SAT admissibility, content, etc. and should include audience acknowledgement. These recordings should be made no earlier than 6 weeks prior to submission.

General

- 1. Submit all competitor forms and an <u>un-edited (one continuous shot)</u> video recording (in .mp4 digital format), prepared in accordance with the requirements listed below, to your region's competition coordinator (CC).
 - The recording must <u>NOT</u> have been previously published on social media or on webcasts. Any submission found to have been previously published will be disqualified.
- 2. The region's CC must submit their competitors' performance videos and forms, via Dropbox, to the Competition Department by their assigned date.
- 3. Once the Competition Department at IHQ receives all video submissions for a region, they will be given to the official panel for adjudication.

Requirements for Recording

- Ideally the device (i.e. mobile phone, tablet, camera, etc.) used to record your performance should be able to record clear quality sound. The recording is to be submitted in .mp4 digital format.
- 2. The performance should be checked to ensure that the quality of the recording is sufficient for an effective evaluation.
- Any microphones used should be used for recording input only, not amplification of any kind.
- Lighting is to be uniform for the entire performance and no special effects are to be used.

- 5. Camera shots should be taken with the Visual Communication judge in mind. Here are some suggestions to keep in mind when recording:
 - A fixed camera full length shot is recommended.
 - The judge needs to see facial expression, choreography, full shots, etc. if possible.
- At the beginning of the recording, an individual is to introduce the contestant, announcing the name of the Chorus/quartet. This announcement may be made by a member of the ensemble.
 - Chorus Announcement: From (name of city) under the direction of (name of director(s)...(NAME OF CHORUS!)
 - Quartet Announcement: From (name of region/name of chorus affiliations)
 (NAME OF QUARTET!)
- 7. The competitor should be in suitable costume and make-up. The make-up should be applied in such a manner that it is appropriate for video performance, highlighting facial features.
- 8. The submitted digital performance is the property of Sweet Adelines International. Competitors may <u>NOT</u> post, or otherwise share, their video recordings until <u>after</u> adjudication and release of results. Permission may be obtained after the results have been posted by contacting the Competition Department.
- 9. The recording should be a continuous, one-take shot video with no editing. Any edited videos will be disqualified.

If your region or festival host is providing a recording event, you may choose to record your contest performance at the event. However, competitors are not required to use this recording as their contest submission.

Official Recordings

All submitted recordings are property of Sweet Adelines International and will not be returned. Any further use of audio or video recordings of competition submissions are at the discretion of the Education Direction Committee (EDC) or the International Board of Directors.

- Submit the file via Google Drive file link for download by CC. Cannot submit via Email, the file will be too large.
- Cannot be a YouTube link.
- Also must include your chorus or quartet posed competition photo as a jpg file.
- Your complete <u>list of competing members with signature</u>. SAI Form is provided. Scan as pdf form to include with video.

Dates and Deadlines

The Regional Convention Committee is providing the following checklist so choruses and quartets can keep track of deadlines. Please meet all deadlines to avoid late charges. Meeting deadlines will also ensure that you are able to compete if you so desire.

IMPORTANT DATES -

- Competitor Entry Deadlines
 - February 8th—for regular entry
 - Chorus Entry Fee—\$150.00—(Late Fee \$250)
 - Quartet Entry Fee \$100.00—(Late Fee—\$200)
 - February 22—for late entry
 - No entries will be permitted after February 22, 2022.
- Competition entry fee is non-transferrable but will be refunded if a competitor needs to withdraw from the competition.

IMPORTANT QUARTET INFORMATION: The paperwork for new and renewing quartets must be submitted and processed before they can register for competition. New quartets or renewal received after FEBRUARY 8, 2022 (60 DAYS PRIOR TO COMPETITION) will be charged additional registration fees.

The late fee of \$250.00 for choruses and \$200.00 for quartets, in addition to the entry fee is assessed to any quartet or chorus for which an entry blank is received at International Headquarters after the deadline dates listed above. The entry fee and late fees are non-refundable and non-transferable.

- Order of Appearance Draw February 14, 2022 -
 - The order will be posted on the SAI website: www.sweetadelineintl.org
- Competitor video submissions due to CC no later than April 4, 2022
- Contest Adjudication will take place April 7-10, 2022.
- Contest results will be sent to CC/CRC within one week of contest adjudication.
- Region 6 will host a virtual convention April 23, 2022. on Facebook Live at 12:00 Noon
- Competition results will be posted on SA International Website May 2, 2022
- Competitors will receive their scoresheets and a copy of results on April 23, 2022.

Copyright Matters

In your competition materials, you will find the certification of Copyright Clearance on the Competition Authorization form. When this form is initialed by the quartet, or by the president/team leader on behalf of the chorus, it states that to the best of your knowledge, the arrangements your group is performing are legal arrangements, either they have been cleared through the copyright process, are original works, or are songs in the public domain. Generally, when you purchase music you can assume that appropriate permissions have been obtained. However, if you are not certain, it is acceptable to ask the music provider to verify that the arrangement has cleared the copyright approval process.

Be aware that lyrics, like the music itself, are copyright protected. Legal issues typically occur only when a performer makes musical or lyrical changes to a published arrangement without permission. Altering a few words to personalize the song for the performer is usually permissible; however, if the lyrical changes involve a parody, with very few exceptions a performer must obtain permissions from the copyright holder to make such changes. Parody lyrics are defined by Jay Althouse in his book, *Copyright: The Complete Guide for Music Educators*. as follows:

"Parody lyrics are lyrics which replace the original lyrics of a vocal work or are added to an instrumental work. In general, any parody lyric or the revision of a lyric that changes the integrity (character) of the work requires authorization from the copyright owner."

Copyright holders have the right to say no to any particular arrangement of their music, and they exercise that right frequently when it comes to parodies. Copyright holders will generally want to review the parody lyrics prior to granting approval or permission to arrange. In addition, when we obtain permission to put your performance on video, copyright holders request copies of all parody lyrics before that permission is considered. As a result, we are now requiring all competitors to attach parody lyrics to the Song Information Sheet so that we are not unduly delayed in our request for licensing. To avoid further complications, and in accordance with the policy adopted by the International Board of Directors, no parodies will be included in our international recordings without written permission from the copyright holders. Obtaining permission to arrange a piece of music with parody lyrics does not guarantee that the copyright holder will grant permission for the video recording.

Sweet Adelines International always tries to comply, to the best of its knowledge and ability, with all applicable copyright and licensing laws of the United States. Use of the certification of copyright clearance form is intended to help you protect the organization from complications resulting from the licensing restrictions. We also recognize that you, as members and performers, want to do the right thing and be in compliance with the law as well. In the future, if it is determined that a contestant has provided false information or has not appropriately obtained permission for an arrangement, and as a result the organization is subject to extraordinary expense, legal fees, or fines, that contestant may be asked to share in these costs. Putting our organization at risk may result in disqualification at international contest.

Weet Adelines GUIDELINES FOR PREPARING A REGIONAL OPEN DIVISION PACKAGE

Each performance will be a maximum of 10 minutes and includes one contest song, any emcee material, and at least one other song. The three to seven (3 to 7) minute timing requirement for the contest song will be suspended. Contestants need to allow for applause when timing the package. The following guidelines should be followed in preparing the Entertainment Package portion of the competition performance:

- All singing must display competence in vocal skills, musical understanding, and lyrical delivery.
- 2. Spoken and special material should be congruent with the theme and script and be acceptable for family audiences.
- The emcee(s) should display preparation, confidence, poise, ease, and a sense of appropriate timing in presentation and in the use of the microphone.
- The planning of the package should reflect creativity in both its content and delivery. Merely singing three competition-type songs and some limited spoken material, for instance, would demonstrate little imaginative preparation.
- For the panel to know which song is to be judged as a contest song, each contestant must submit a performance outline at the competition briefing.



GUIDELINES FOR JUDGING THE REGIONAL OPEN DIVISION PACKAGE

Each judge will score the contest song of the package in accordance with the requirements for their respective category and award a level for the contest song.

Each judge will also award a level for the complete package. In awarding the score for the overall performance, judges will consider:

- 1. Musicality: Does the quartet or chorus sing with vocal and barbershop skill, i.e. good vocal production, in tune, and with appropriate tempos and word delivery? Is the musical delivery appropriate to the genre being sung?
- 2. **Unity**: Does the quartet or chorus perform as a unit with attention to energy, musicality and blend?
- 3. Planning: Does the presentation demonstrate a cohesive theme with a well-planned story arc? Does the script allow for character development, stagecraft and music choices that support that theme? Does the action onstage move at a pace and in a manner that draws the audience into the performance? Does the stagecraft (props, costumes, makeup, blocking, lighting) support the overall plan?
- 4. **Creativity**: Does the quartet or chorus present a 10-minute package that exhibits imaginative preparation and execution?
- 5. **Audience Connection:** Does the quartet or chorus demonstrate their commitment to audience rapport and reaction?

Scoresheet comments are written for the contest song and for the other song(s) and spoken material included within the package.
